Subject: Cease and Desist Defamatory Statements

Dear [Recipient's Name],

I am writing to formally address false and defamatory statements you have made concerning me/us, which have caused significant harm to my/our reputation, personal relationships, and professional standing. The statements in question include but are not limited to [specify defamatory statements or conduct]. Failure to comply with these demands will leave me/us no choice but to pursue all available legal remedies, including filing a civil lawsuit seeking damages, injunctive relief, and attorney's fees. Please also be advised that defamation lawsuits carry a significant risk of adverse legal consequences, including potential punitive damages where malice is proven.

This letter does not constitute a complete or exhaustive statement of my/our rights or remedies, all of which are hereby expressly reserved.
