Terms and Conditions:

1. Enrollment and Care

Provider agrees to provide daycare services for the Child named above during the days and hours agreed. Provider shall maintain a safe and healthy environment compliant with applicable state and local regulations.

2. Health and Safety

Parent/Guardian certifies that the Child is physically fit to attend daycare and agrees to notify Provider promptly of any health issues, contagious diseases, or allergies. Provider shall follow standard safety protocols and emergency procedures.

3. Payment and Fees

Parent/Guardian agrees to pay all fees timely as described above. Late payments may incur additional charges. Fees are non-refundable except as required by law. Provider retains the right to suspend services for non-payment.

4. Termination of Services

Either party may terminate this Agreement upon written notice. Provider reserves the right to terminate services immediately for non-compliance with policies, non-payment, or behavior issues threatening safety.

5. Liability and Indemnification

Provider is not liable for any injury, illness, or loss arising during daycare except where caused by Provider's negligence or willful misconduct. Parent/Guardian agrees to indemnify and hold Provider harmless from claims arising from the Child's actions.

6. Confidentiality

Provider will maintain confidentiality of the Child's and Parent/Guardian's personal information except as required by law or for the provision of services.

7. Governing Law and Dispute Resolution

This Agreement shall be governed by the laws of the State of _____. Any disputes shall be resolved through mediation or arbitration prior to litigation.

8. Entire Agreement

This document constitutes the entire Agreement between Provider and Parent/Guardian. No other promises or representations are binding unless made in writing and signed by both parties.

9. Emergency Authorization

Parent/Guardian authorizes Provider to seek medical treatment for the Child in an emergency if Parent/Guardian cannot be reached.

10. Waiver and Severability

Failure to enforce any provision does not waive the right to enforce it later. If any provision is invalid, the remainder remains effective.
