Property Description and Location:

The undersigned property owner hereby grants permission to the Hunter named above to enter the described property for the purpose of hunting lawful game species in accordance with all applicable federal, state, and local laws. 10. The Hunter shall clean up all trash, spent ammunition, blinds, stands, or other equipment brought onto the property during the hunt.
11. The Hunter acknowledges that hunting is inherently dangerous and agrees to exercise caution and utilize appropriate safety equipment.
12. The Hunter shall inform the Property Owner of any incidents, injuries, or violations related to hunting activities on the property.

Legal and Compliance Statements:

This Hunting Permission Letter is governed by and shall be construed in accordance with the laws of the United States and the applicable state jurisdiction. Any disputes arising hereunder shall be subject to the exclusive jurisdiction and venue of the courts located within the applicable county and state.
