Re: Notice of Default under Agreement

Dear Sir or Madam,

This letter constitutes a formal NOTICE OF DEFAULT pursuant to the terms and conditions of the agreement entered into between the undersigned parties (the "Agreement").

- 2. Comply fully with all remaining covenants and conditions of the Agreement.**
- 3. Provide any outstanding documentation or information requested in writing.**
- 4. Communicate promptly with the undersigned to confirm resolution of the default(s).**

If you fail to cure the default(s) within the cure period, the undersigned reserves all rights to pursue any and all legal and equitable remedies as provided under the Agreement and the laws of the United States, including but not limited to:

- 1. Termination of the Agreement.**
- 2. Demand for immediate payment of all outstanding obligations.**
- 3. Initiation of collection or legal proceedings.**
- 4. Recovery of costs, attorneys' fees, and damages incurred as a result of the default.**

This Notice is provided in accordance with the terms of the Agreement and is intended to be legally binding and enforceable under United States law.

Nothing contained herein shall be construed as a waiver of any rights or remedies available to the undersigned except as expressly stated herein.
