

YOUTH BASEBALL TEAM SPONSORSHIP AGREEMENT

Introduction:

This Sponsorship Agreement (the "Agreement") is entered into between the Sponsor named above and the Youth Baseball Team (the "Team"). The purpose of this Agreement is to establish the terms and conditions under which the Sponsor agrees to provide financial support to the Team, and the Team agrees to promote the Sponsor in accordance with the terms set forth herein.

Sponsorship Details:

1. Sponsorship Amount: The Sponsor agrees to provide the Team with a sponsorship contribution in the amount agreed upon by both parties. This amount shall be payable according to the schedule set forth in this Agreement. 2. Payment Schedule: Payments shall be made as follows: [Specify Payment Terms]. 3. Either party may terminate this Agreement upon written notice to the other party if there is a material breach that remains uncured after a reasonable opportunity to cure. Termination shall not relieve the Sponsor of payment obligations accrued prior to termination.

Sponsor Obligations:

The Sponsor represents and warrants that all materials provided for promotional use (logos, trademarks, slogans, images) do not infringe on any third party rights and comply with all applicable laws. The Sponsor agrees to deliver such materials in a timely manner and to cooperate with the Team in promotional activities.

Team Obligations:

The Team agrees to promote the Sponsor's name, logo, and other agreed upon materials as specified under Sponsor Benefits. The Team shall use the sponsorship funds solely for the purposes described in this Agreement and provide reasonable documentation of expenditures upon request.

Indemnification and Liability:

Each party agrees to indemnify, defend, and hold harmless the other party, its officers, agents, and employees from and against any and all claims, damages, liabilities, and expenses arising out of any breach of this Agreement or negligence of the indemnifying party, except to the extent caused by the other party's gross negligence or willful misconduct. Neither party shall be liable for incidental, consequential, or punitive damages arising from this Agreement.

Confidentiality:

Both parties agree to maintain confidentiality with respect to sensitive information disclosed during the course of this Agreement, except as required by law or with prior written consent of the other party.

Governing Law and Dispute Resolution:

This Agreement shall be governed by and construed in accordance with the laws of the State of _____, without regard to its conflict of laws principles. Any disputes arising out of or relating to this Agreement shall be resolved through good faith negotiation between the parties. If unresolved, disputes shall be submitted to binding arbitration in accordance with the rules of the American Arbitration Association, with the location agreed by the parties.

Entire Agreement and Amendments:

This Agreement constitutes the entire agreement between the parties regarding the subject matter hereof and supersedes all prior negotiations, understandings, and agreements. No amendment or modification shall be effective unless made in writing and signed by both parties.
